- If you make contact with Liz Reece Careers using the contacts page then I will have your email address and name. Your enquiry will be answered in person by Liz Reece and no further contacts made if you do not request this.
- If you decide to engage Liz Reece's services then your personal data will be collected as explained below in **retaining your personal data**.

Security

- I am committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, I have put in place suitable and practicable procedures to safeguard and secure the information I collect.
- If there were a breach of security I would report it to the Information Commissioner's Office.

How I use cookies on the website

- A cookie is a small file which asks permission to be placed on your computer's hard drive. Liz Reece uses traffic log cookies to identify and count which pages are being used and the country location of users so that she can improve the website for you as customers. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.
- You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.

Retaining your personal data
